EXPLANATORY REPORT

Who is the planning authority?

This amendment has been prepared by Moonee Valley City Council, who is the planning authority for this amendment.

The Amendment has been made at the request of Moonee Valley City Council.

Land affected by the amendment

The amendment applies to 57 individual heritage places, 9 extended heritage precincts, 17 new heritage precincts and 1 serial listing as detailed in this report.

A mapping reference table is attached at Attachment A to this Explanatory Report.

What the amendment does

The amendment applies the Heritage Overlay to 57 individual heritage places, 9 extended heritage precincts, 17 new heritage precincts and 1 serial listing, introduces Statements of Significance in the Schedule to the Heritage Overlay and updates the incorporated document *City of Moonee Valley Permit Exemptions Policy – Heritage Overlay Precincts, April 2021* to include the additional heritage places and precincts.

Specifically, the amendment:

1. Amends the Schedule to Clause 43.01 (Heritage Overlay) and Planning Scheme Map Nos. 8HO, 11HO, 12HO and 15HO in relation to the 9 extended heritage precincts shown on Table 1 (below);

6. Replaces the schedule to Clause 72.04 (Documents Incorporated in this Planning Scheme) to include all new and revised Statement of Significance and an update *City of Moonee Valley Permit Exemptions Policy – Heritage Overlay Precincts, May 2019* which includes the additional precincts and extensions to precincts.

Strategic assessment of the amendment

Why is the amendment required?

One of the objectives of the *Planning and Environment Act 1987* ('the Act'), at section 4(1)(d), is 'to conserve and enhance those buildings, areas or other places which are of scientific, aesthetic, architectural or historical interest, or otherwise of special cultural value'.

The amendment will assist Moonee Valley City Council with fulfilling this objective of the Act.

The planning scheme is the most appropriate means of protecting local heritage, as the Heritage Overlay protects the heritage fabric of a building and streetscape from unsympathetic alterations and impacts.

Moonee Valley City Council adopted the Moonee Valley Gap Study ('Gap Study') on 25 November 2014. The Gap Study identifies places and precincts that may have heritage significance. The Gap Study informs the scope of the *Moonee Valley 2017 Heritage Study* ('2017 Heritage Study'), which assesses approximately 3,000 Victorian, Edwardian and interwar residential properties.

The amendment reduces the number of urgent heritage assessments as a result of Section 29A applications under the *Building Act 1993*.

How does the amendment implement the objectives of planning in Victoria?

The amendment implements the following objectives of planning in Victoria, under Section 4 of the Act:

- 4(1)(a) to provide for the fair, orderly, economic and sustainable use, and development of land.
- 4(1)(d) to conserve and enhance those buildings, areas or other places which are of scientific, aesthetic, architectural or historical interest, or otherwise of special cultural value;
- 4(1)(f) to facilitate development in accordance with the objectives set out in paragraph (d);
- 4(1)(g) to balance present and future interests of all Victorians.

The amendment implements these objectives by protecting locally significant heritage places in the City of Moonee Valley.

How does the amendment address any environmental, social and economic effects?

Environmental and social effects

The amendment is expected to have positive environmental and social effects as it protects locally significant heritage places in the City of Moonee Valley.

Economic effects

The amendment is not expected to have any adverse or significant economic repercussions for the community.

However, some additional costs are likely to be imposed on the owners or developers of land affected by the amendment, as the amendment will necessitate a planning permit for most buildings and works. The amendment may also affect redevelopment opportunities.

It is considered that the economic costs to individuals will be offset by the benefits to the broader community of protecting places of heritage significance, which will result in a net community benefit.

Does the amendment address relevant bushfire risk?

The affected land is within an established urban area in metropolitan Melbourne and is not subject to bushfire risk.

Does the amendment comply with the requirements of any Minister's Direction applicable to the amendment?

The amendment is consistent with *Ministerial Direction No. 9 – Metropolitan Strategy (Plan Melbourne)*, as it accords with the following direction and policy of Plan Melbourne 2017-2050:

• Direction 4.4 – Respect Melbourne's heritage as we build for the future

This direction seeks to ensure that heritage is valued when managing growth and change. It acknowledges that Melbourne is recognised for its well-preserved heritage buildings and that there is a need to manage future growth and change so Melbourne's distinctive characteristics and heritage are maintained.

Policy 4.4.1- Recognising the value of heritage when managing growth and change

This policy aims to protect Melbourne's heritage and improve heritage management processes within the Victoria planning system.

The amendment is consistent with the *Ministerial Direction No.* 11 – *Strategic Assessments of Amendments* as discussed in this report and complies with the requirements of the *Ministerial Direction on the Form and Content of Planning Schemes* (section 7(5)) of the Act.

How does the amendment support or implement the Planning Policy Framework and any adopted State policy?

The amendment is consistent with the Planning Policy Framework, in particular:

- Clause 15.03-1S (Heritage conservation) and implements the policy by applying the Heritage Overlay to heritage places.
- Clause 15.03-1L (Heritage Conservation) by ensuring the restoration of heritage places and facilitating their reconstruction.

Does the amendment make proper use of the Victoria Planning Provisions?

The Heritage Overlay is the most appropriate mechanism for recognising and protecting the cultural heritage significance of the identified heritage places.

How does the amendment address the views of any relevant agency?

No views were received in respect of the amendment, including Heritage Victoria.

Does the amendment address relevant requirements of the Transport Integration Act 2010?

The amendment is not expected to have an impact on the Transport Integration Act 2010, as the application of the Heritage Overlay is not expected to have any significant effect on the transport network.

Resource and administrative costs

 What impact will the new planning provisions have on the resource and administrative costs of the responsible authority?

The amendment is expected to result in a modest increase in planning applications resulting from the application of the Heritage Overlay to 57 individual heritage places, 9 extended heritage precincts, 17 new heritage precincts and 1 serial listing.
