

Prevention of Family Violence Policy

Purpose

The purpose of this policy is to assist all Council staff to strengthen family violence prevention and respond to the needs of victim-survivors through Council planning and engagement with residents of all ages and backgrounds through Council's range of diverse spaces, places and services.

Scope

The policy includes:

- Statement of Commitment to the Prevention of Family Violence
- Prevention of Family Violence Guiding Principles

This policy applies to Council staff including contingent labour, contractors, consultants and volunteers.

Policy statement

Statement of Commitment to the Prevention of Family Violence:

Moonee Valley City Council believes that everyone deserves to live free from violence.

Family violence is a violation of human rights and is unacceptable in all its forms. Everyone has a role to play in preventing and responding to family violence.

We commit to engaging with the community to strengthen family violence prevention and response in all the work we do.

Policy principles

Prevention of Family Violence Guiding Principles:

- Family violence is unacceptable in all its forms
- Family violence is a human rights violation and preventing it is a health and wellbeing priority
- Everyone has a role to play in preventing and responding to family violence
- Children are victim-survivors in their own right, and their voices and experiences must be heard
- Family violence is perpetrated in many ways and some community members are targeted and impacted more than others
- Unique forms of family violence are experienced by different community groups



- Different forms of inequality intersect to cause family violence in our community
- A whole-of-Council approach to prevention of family violence is necessary
- Partnerships and collaboration across Council, local organisations and community are essential to successful prevention and response to family violence
- Connection with lived experience advocates and the specialist family violence response sector is vital to our work
- Alignment of our action plans for priority populations and family violence prevention work with regional, state and federal prevention strategies is vital for success
- Continuous improvement of our prevention strategies is required through evidence based and best practice approaches, data collection, monitoring and evaluation

Term	Definition					
Family violence	'Family violence' is behaviour by a person towards a family member that is any of the following: physically, sexually, emotionally, psychologically or economically abusive; threatening; coercive; in any other way controls or dominates the family member and causes that family member to feel fear for the safety or wellbeing of that family member or another person; or behaviour by a person that causes a child to hear or witness, or otherwise be exposed to the effects of, violent behaviour referred to.					
Family	'Family' can mean intimate relationships, extended families, kinship networks, intergenerational relationships and family-like or carer relationships.
